THESE PROGRAMS ARE DESIGNED TO PROVIDE A ROBUST SUPPORT NETWORK FOR REFUGEES DURING THEIR TRANSITION INTO NEW COMMUNITIES. THEY FACILITATE VARIOUS ASPECTS OF THE RESETTLEMENT PROCESS, INCLUDING INITIAL PLACEMENT, HOUSING SUPPORT, AND COMPREHENSIVE ORIENTATION ABOUT LIFE IN THEIR NEW LOCATION. THESE PROGRAMS ALSO EMPHASIZE SELF-SUFFICIENCY BY PROVIDING REFUGEES WITH NECESSARY TOOLS AND RESOURCES, SUCH AS LANGUAGE CLASSES, JOB TRAINING, EDUCATION SUPPORT, AND ACCESS HEALTH SERVICES. U4U STRIVES TO EMPOWER REFUGEES, HELPING THEM BECOME ACTIVE, CONTRIBUTING MEMBERS OF THEIR COMMUNITIES.
